Dear Oblates,

Recently I had the privilege, along with Oblate Barb Rezac, of attending the “Oblates for the Future Symposium” at St. Gertrude’s Monastery in Cottonwood, Idaho. There were over 40 monastics and oblates present to help plan the future of Benedictine Oblates.

The symposium had three main goals: naming the current reality between the monastics and oblates, naming and claiming a vision of the future, and the next steps and plans to move into the future.

Sister Mary Forman OSB, prioress of St. Gertrude’s Monastery, gave the keynote address, “Oblates in the Christian History of Religious Life.” She gave an excellent presentation on the history of monastic life throughout the centuries. There have always been adult oblates associated with Benedictine Monasteries from the Middle Ages to the modern years. The current reality is that the aging monastic communities are decreasing in size, and the oblates are increasing in number. On the part of both the monastics and oblates, there is a sense of grief, and it is unclear how to deal with the loss.

The vision for the future of the oblates is that they are called to be more than “friends of the monasteries” but to take oblation as a life commitment to live Benedictine spirituality in all aspects of their lives. To be Benedictine Oblates can be seen as a form of a vocation, in the sense of being a call from God. Oblates will be more involved in the Benedictine Community, living in the world with an emphasis on their relationship with their Benedictine Community.

It seems more monasteries are organizing their oblate groups with a special emphasis on the formation of the oblates. Dr. Charles Van Leeuwen of Belgium spoke of the need for solid formation for the oblates. This formation is not only for initial formation before making oblation but there is a strong emphasis on how oblates continue to live their Benedictine commitment, and how they continue to develop and grow in their spiritual life. Dr. Van Leeuwen said, “The spiritual life is an attitude of mind we must develop. Conversion requires us to grow and change, and requires on-going formation. The credibility of the oblate membership depends on it. The better the formation, the better the oblates are, and the better the community is.”

In most of the monasteries that were represented at the symposium, some form of appointed or elected oblate group shared responsibility with a monastic co-leader. In some cases the oblates took the total leadership of the oblate group; in others, the monastics still had all the leadership roles.

Sister Teresa Jackson, OSB, of St. Gertrude’s Monastery ended the symposium with these words, “Embracing oblates as people with a different, yet vital Benedictine vocation, can allow monastics to see co-workers in the vineyard. Oblates can become the people who take our mission and charism to places we can no longer go. If oblates are seen as having a vocation, then formation matters. If formation matters, then oblates have a stake in the coordination and leadership in their groups.”

Each monastic community and oblate group present was asked to focus on the next steps they will take in their communities when they return home. The symposium emphasized the need to have shared conversations about the identity and role of Benedictine oblates today. Participants were encouraged to discuss these ideas with other oblates and with members of their monastic community.

A second “Oblates for the Future Symposium” has been planned for September 9-13, 2019. Next year will be focused on Benedictine formation for oblates as well as supporting oblates’ directors in developing a stronger role for oblates in our Benedictine monasteries.

It seems that, as oblates of Sacred Heart Monastery, we will have some things to reflect about in the coming year.


